The purpose of the Foundation is captured by the mission statement above. We seek to enable God's mission now and into the future in a number of ways:

- through personal endowment funds where donors set up an endowment to support ministries, mission activities, and other charitable acts that are important to them (a minimum of \$50,000 must be established over time for such endowments)
- through the Mission Focus Funds established by the Foundation to enable a variety of ministry activities through Seeds of Hope grants
- through the Congregational Investment Program, which allows congregations to have reserve funds managed through the Foundation with Fiera Capital, the Foundation's Fund Manager
- through individual gift funds that allow people to give a special gift (cash, securities, or other immediate gifts) to a congregation, outreach ministry, or mission partner
