### PROMOTING ALTERNATIVE IMAGES OF AFRICA IN CANADA'S SCHOOLS

"Promoting Alternative Images of Africa in Canada's Schools" is a project of the Justice, Global and Ecumenical Relations Unit of The United Church of Canada, working in partnership with Canadian and African organizations. It is designed for teachers in elementary, secondary, church and other schools. Financial support from the General Endowment Fund and the Brian and Belva Piercy Fund of The United Church of Canada Foundation will help distribute resources to teachers so they can present images and information about African people and cultures that are not usually conveyed through mainstream media sources. Lesson modules will be distributed free of charge through the website of AfricaFiles, one of the partners in the project (www.africafiles.org).

### EARTHQUAKE RELIEF IN JAVA

A grant from the Davey Family Endowed Fund supplemented the response of Action by Churches Together (ACT) to the May 27, 2006 earthquake in Java. ACT funding allowed local partners to respond immediately with food, clean water, emergency medical care and short-term housing, as well as to develop a longer-term response plan.

## REBUILDING IN HOPE

Arsonists destroyed Minnedosa United Church on February 12, 2006. Flames even consumed the one thousand kilograms of food collected and stored for the local food bank. As worshippers began raising funds and interviewing architects, someone living 2,500 km. away asked The United Church of Canada Foundation to convey his generous gift to the church of his childhood.

### BUILDING RELATIONSHIPS, ENDING VIOLENCE

Poverty and conflict are breeding a culture of violence among disadvantaged youth across our country. Last year, Kofi Hope, leader of the Black Youth Coalition Against Violence, signed on as the animator of a United Church program to build relationships and leadership among young people throughout Canada. Two anonymous donors poured over \$50,000 into this work of justice and healing through The United Church of Canada Foundation.





### ABOUT OUR INVESTMENTS

The United Church of Canada Foundation has adopted the policy of socially responsible investing developed by The United Church of Canada. Under that policy, we have chosen to invest in a balanced pooled fund managed by Fiera YMG Capital. That company's predecessor, YMG, has served the United Church well for several years. The fund the Foundation has chosen adheres closely to the socially responsible investment requirements of the Church and the Foundation. In 2006, the Foundation's endowment funds earned 11.95%, with a management fee of just 0.2%

Such institutional funds are normally available only to institutions with significant assets to invest. However, because of its relationship with the United Church and the Foundation, Fiera YMG offers other United Church organizations — congregations, camps, colleges, Presbyteries and Conferences—the opportunity to participate in the balanced fund the Foundation has chosen

By the end of 2006, 22 congregations and other United Church organizations working through the Foundation invested over \$9,500,000 in the Foundation's investment program. They too earned 11.95% on their investment in the year ending December 31. (The five-year average return on the fund was 9.59%) The administrative charge for congregations and organizations is just 1%. Of that modest fee, the Foundation retains 4/5 as a contribution to its own operational costs, while the manager receives the remaining 1/5 of 1%. The Foundation is delighted to offer this opportunity to enhance the stewardship of congregational and organizational endowments.
